OF DANGERS, RISKS AND HAZARDS
OF HUNTING with Dore Mountain Outfitters LTD.**

I hereby acknowledge that I have knowingly and willingly enter into this Hunting Agreement for a hunt by and between Dore Mountain Outfitters LTD. (also known as outfitter) dated _____. I understand the terms, provisions and conditions of that Hunting Agreement and agree to abide by its terms, provisions and conditions.

I further acknowledge and understand that no warranty, either express or implied, is made by the Dore Mountain Outfitters LTD. as to the condition of the hunt.

This document serves to warn me those dangerous conditions, risks And hazards do exist. My presence and activities on the outfitting area Expose both me and my property to dangerous conditions, risks and Hazards, including but not limited to: Quad transportation, boat transportation, snowmobile transportation, insects and Spiders; blinds and tree stands, whether or not erected by Outfitter, erosion and general condition of the land, both on and off roadways creating rough, hazardous and dangerous driving and walking conditions; animals both wild and domestic that maybe diseased and/or potentially dangerous; deep water; persons with firearms both on or off the outfitting area premises; and the use of vehicles. I hereby state that I am aware of these facts and expressly assume all such dangers, risks and hazards.

In consideration for the purchased hunt, I hereby release And agree to protect, indemnify and hold harmless the outfitter and his or her respective heirs, agents, employees and assigns from and against any and all claims, demands, causes of action and damages, including attorneys' fees, resulting from any accident, incident or occurrence arising out of, incidental to or in any way resulting from the hunt, whether or not caused by the Outfitters negligence or gross negligence. I hereby further covenant and agree

That I, my heirs, successors and assigns will not make any claim or institute any suit or action at law or in equity against the Outfitter or his or her respective heirs, agents, representatives, employees, successors or assigns by reason of conditions of the hunt or activities occurring Thereon.

As used in this release, the terms *I*, *my person* and *myself* include minors In my care while on the outfitting area.

I have carefully read and understand Dore Mountain Outfitters LTD. Rules and Regulations and agree to all stated conditions set forth therein, including my responsibilities and obligations as a guest on the hunt.

I have carefully read this agreement. I understand that it is a release of liability and a legally binding contract between me and Dore Mountain Outfitters LTD. and/or its owners and I sign this agreement of my own free will.

Rules

1. Dore Mountain Outfitters LTD. strives for trophy management and bucks over 130" Boone and Crockett are minimal expected harvest by hunters.
2. No alcohol while hunting or while being transported to and from the hunt
3. Once you shoot at a animal immediately call your guide and wait until guide arrives before looking for your animal , **do not continue hunting** ,the harvest of two animals is illegal and delt with very strictly by Canadian government.
4. If blood is drawn consider your tag filled whether animal is found or not.
5. keep your license, firearms declaration form and tag with you at all times.
6. No smoking in stands of vehicle going to and from stands.
7. It is your responsibility to take seat cushion, bunson burner (sterno) and radio with you to stand each day.

Saskatchewan Regulations

It is illegal to

- Shoot across any roadways or grid road.
- Use of any artificial light, night vision, scopes or goggles.
- Carry loaded firearm in any vehicle
- Hunt without wearing complete outer suit of scarlet, bright orange, bright yellow, blaze orange, or white or any combination of these colors. Headwear must be any one of these colors except white.
- Hunt wildlife from one half hour after sunset to one half hour before sunrise.
